Revive accepts: Items in new or new-like condition sizes XS-XL. Women’s Clothing, Shoes, Designer Hand bags, Hats, Scarfs, Outerwear, Jewelry.

Please have items ready for resale:

- Clean, wrinkle-free, no snags, no stains, no odors, no smoke, no moth ball smell, no pet hair
- Must be **CASUAL styles** and Trendy name brands, **no older than three years, XS/0-XL/16 Only.**
- **60 items limit, 15 items minimum** per appointment
- **We do not accept:** 2XL and above, (H+M, Forever 21, Target, Wal-Mart, Kmart, Old Navy etc) , No vintage, anything with shoulder pads, professional wear(suits, blazers),grams attic items,bras, wedding dresses, PJs, lingerie, mens, childrens, glass ware,furniture,home décor,house items,high heels.

Consignor info:

- **NO FEE** to open a consign account. **NO FEE** for online access, www.revivenj.consigncloud.com.
- **Payment choices:** **40%** of selling price once item is sold by check OR **45%** of the selling price if you keep your funds in store credit only, must be spent at Revive, Never expires, Nontransferable. No exceptions.
- Designer bags: receive **50%** of the selling price. (LV, Gucci, Chanel Bags receive **70%**).
- Checks are mailed at the end of each month over \$20, under \$20 pickup cash in store. Revive is not responsible for lost checks. Bank fee is \$30 to cancel and resend check at consignor’s expense.
- Revive sets appropriate price for all items. About 80% off original price. If you purchased it new for \$100 it will be priced around \$20 at Revive.
- Every item has a buyers fee that helps pay for free accounts and other store amenities. The buyers fee is paid by the buyer. Example: Items will be \$9 in your account, \$10 in store, \$1 buyers fee.
- We often have sales to move merchandise. Revive reserves the right to reduce the price without consulting the consignor, up to 50% off.
- Items cannot be removed from Revive until day 60, Items removed before day 60 is breach of this contract and we can no longer accept items from you in the future.
- It is illegal to sell fake Designer purses, Revive has to pay a professional service to verify Designer bags. If your purse can not be authenticated by our specialists you are responsible to pay for the cost \$15.
- Items will be given love and care but Revive is not responsible for theft, damages, fire or acts of nature.
- Revive items are held on the sales floor for 60 days from the date they are entered in the system. During this time Revive will do their best to merchandise and promote your items. After 60 days your items will enter a grace period for 5 days during which time you must call Revive to prepare your items and pick them up with in the 5 days. At the end of the grace period, Revive LLC will solely own items not picked up. It is the consignor’s responsibility to check their online account for when items expire (revivenj.consigncloud.com) and email/call for pick up or it will be donated to local charities. No exceptions.
- **I want my items: Returned to me** **or Donate to local needy charity**
- Revive reserves the right to end this contract .Upon termination any unsold items still under contract can be picked up within 5 days of notification. You will be paid on sold items.
